## Privacy & Security Policy

Your privacy is very important to Hotel Indigo Austin Downtown-University. To help protect your privacy, we adhere to the following guidelines.

- Hotel Indigo Austin Downtown-University will explicitly ask when it needs information that personally identifies our customers or allows it to contact our customers (Personal Information). Generally this information is requested when making reservations, joining the IHG Rewards Club® Worldwide frequent traveler program, registering for a site, when requesting a particular service, or when entering a contest. When possible, Hotel Indigo Austin Downtown-University will provide our customers with the means to make sure that your Personal Information is correct and current.
- Hotel Indigo Austin Downtown-University and its service providers use Personal Information to operate the site, provide services, and to inform our customers of new features, services, and products. Hotel Indigo Austin Downtown-University may also carefully select other companies to send our customers information about their products or services (a Secondary Use).
- If Hotel Indigo Austin Downtown-University intends to use Personal Information for a Secondary Use, Hotel Indigo Austin Downtown-University will not do so until we have provided our customers with an opportunity to affirmatively select such service
- Hotel Indigo Austin Downtown-University may disclose Personal Information if required to do so by law or in the good-faith belief that such action is necessary to (a) comply with applicable law or with legal process served on Hotel Indigo Austin Downtown-University or the site; (b) protect and defend the rights or property of Hotel Indigo Austin Downtown-University or this site, and (c) act under exigent circumstances to protect the personal safety of users of Hotel Indigo Austin Downtown-University hotels, the site, or the public.

Our customers should also be aware that information and data may be automatically collected through the standard operation of our internet servers and through the use of cookies.
